However, no one can predict how any SA will react in a given situation without full knowledge of its life experiences before rescue. Therefore, adopters are strongly urged to exercise caution in introducing an adopted Stuffed Animal into new situations until he or she has become fully adjusted to the new environment and the adopter has had an opportunity to become familiar with the SA's unique personality. The S.A.R.F. makes no claims or warranties regarding the temperament, behavior or future health of any RSA.

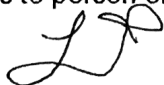
Stuffed Animals are not working or sporting animals. They should be adopted solely for companionship. Although many SA's love daily walks with human companions, an SA's physical structure (i.e., inanimate body, non-self-mobile legs, porous fur, stuffed internal cavity) make it unsuitable for living outdoors or for participating in rigorous self-initiated exercise like walking, jogging or playing fetch.

This SA has received all immunizations and is in suitable health for adoption. However, we do recommend microchip implants in all SA's to insure safe return in the unfortunate event of loss or SA-napping.

This contract is made between The S.A.R.F. as represented by the member whose signature appears below and the adopter whose signature appears below. The adopter agrees to:

1. Provide this Stuffed Animal with adequate shelter, substantial hugs, proper food if applicable, and lifetime companionship.
2. Comply with all state and local laws and ordinances related to SA's, including maintaining proper licenses and observing leash laws (only applicable to stuffed dogs).
3. Never allow this SA to be used for experimentation, fighting, or any other commercial illegal activity.
4. Provide The S.A.R.F. with at least one photograph of yourself and your newly adopted SA for use on The S.A.R.F. website.
